## PRESENTATIONS FROM SATSOP SCHOOL MEMBERS:

- 1. Modernization Grant/Construction Update: Adam Wilson from Rock Project Management gave an update on the construction progress. He said this week is a milestone week for the project due to several things taking place. First is the slab on grade/concrete floors will be done this Friday including the new ADA ramp/steps. Next up will be laying the asphalt down for the parking lot, start working on the construction of the new gym walls and installing the water tank, pump house and fire hydrant. He also said there have been a couple of unforeseen discoveries, such as some mold and dry rot issues. The mold has been mitigated. Some of the dry rot has also been mitigated and the rest we will hold off on until the end of the project to see if there are funds left in the budget to mitigate. If not, we will look for other funding, such as the Urgent Repair grant, to help fund the mitigation cost to repair the rest of the dry rot in the future.
- 2. Tiffany Osgood informed us that our new insurance company, WSRMP is requiring us to run MVR's on all parent volunteers. We will implement this process starting this 25-26 school year.
- 3. Tiffany Osgood shared that Vincent Reese procured a new double stall metal cover for our 2 vans that are housed at the Elma School District. She showed us a picture of the vans under the new cover.
- 4. Dawn Siemiller discussed the final ending General Fund balance for the 24-25 school year. We budgeted for an ending 24-25 fund balance of \$506,995 and our actual final ending fund balance is \$881,140.66. This is due to higher enrollment and budgeting very conservatively for revenues. Dawn also shared that we were awarded Safety Net funds of approximately \$85,000 to reimburse the district for Olympic Academy costs.
